





From interviews with Sexual Assault Forensic Examiners in which ED MDs wrote prescriptions for HIV prophylaxis, barriers encountered by patients ranged from providers inconsistently offering prescriptions for the correct medication, difficulty locating a local pharmacy stocking the medication, additional access steps needed by uninsured patients while feeling overwhelmed, emotional distress and fear of acquiring HIV leading to lack of comprehension of instructions, and possibility of 28 day pill regimen being a daily reminder of the assault. Multiple strategies to counteract these barriers are discussed.





Receiving the resources vs. the thank you card made no difference – the questionnaire and interview were perceived to be more helpful.

From an ongoing study of mothers, maternal ACEs were associated with increased marital conflict; however, this association was reduced when there were high levels of neighborhood collective efficacy – feelings of security, trust, order, and connectedness with others.
